Monday Night

Purchase of additional equipment for the new Webster elementary school cafeteria and appearance of a small delegation of Negro parents were featured at a meeting of the Hillsboro board of education Monday night at the administration building.

The board discussed operation of the Webster School cafeteria, now nearing completion, and authorized purchase of serving equipment for that unit

The Negro group renewed their previous demands for immediate integration. The board reiterated its previous stand of accomplishing integration when the two new schools are completed. The clash ended in its usual stalemate.

FOR THE new cafeteria, the board authorized the purchase of 300 stainless steel -trays, knives, forks and spoons, plus soup bowls. The board decided on the trays instead of sets of dishes.

Harold Henry, Webster principal. said that all equipment has been installed but a few minor details remain to be completed at the cafeteria. No action was taken on hiring of a cook for the Webster cafeteria although several applications were reviewed.

The parents appearing before the board included Mr. and Mrs. Orval Curtis and Mrs. Glenn Speach. Curtis suggested that the board and the Negro parents "thrash out the thing among ourselves without court action." He accused Marvel Wilkin as the member of the board holding up such an out-of-court settlement.

Mrs. Curtis charged that the board has gone back on its word of integrating Lincoln children next year. Board members denied this. They pointed out that their original action merely stated that they would integrate Lincoln children upon completion of the two new schools, not naming any specific date. Of course, they added, they hope to have Washington School back in operation by September,

THE DELEGATION again denied that Philip Partridge, who set fire to the Lincoln School on July 5, 1954, had anything to do with their

THE BOARD made the following athletic assignments of coaches: Varsity basketball, Ray Oliver; Robert Hamm, reserve basketball; George Williams, junior high basketball.

A heating and glare problem in the classrooms in the south wing of the new Webster School was discussed but no further action will be taken until architects make a further study and recommend a solution.

A check is to be made of the cost of drapery materials for the multiple-purpose room, so that the room may be darkened for showing of movies.

The board also approved the purchase of new sewing machines for the high school economics department. Eight new machines were purchased from the Pence Sewing Machine Company, trading in four old machines.
