School, leasing of a section of school ground to a business firm and planning for redecoration of the interior of the high school. Discussion of new buildings and other matters was also held.

The levy has been under consideration for several months. For the calendar year of 1955, school districts, under a new law, must have at least 10 mills of local taxation before they can be granted state funds. The additional levy here is designed to bring local millage up to the requirement and to provide additional income for additional teachers and expenses during the next few years.

The local school expects to receive a total of \$153,483.98 from the state foundation program during 1954. This or an approximate amount would be lost next year if action is not taken on the levy, board members said. They said that three mills would meet the requirements of the additional millage and higher operating costs. Local schools receive more than half of their income from state funds.

Superintendent Paul L. Upp said vacancies still exist for the posts of head football coach, industrial arts, French-Latin, English, bookkeeping, general business and general math. The elementary staff is now complete. Part of the board session was devoted to going over applications for the football coaching job but no definite decision was reached. Approximately 40 applied for the post. Six were given serious consideration. Salary is expected to be about \$4,000.

THE BOARD, by a vote of 3 to 1, with one member absent, leased a lot lying just east of the school administration building, to the Matson automobile agency and garage. The lease is for three years for an annual rental of \$500. The firm plans to level and improve the lot, which lies directly north across West Main Street from the Matson agency. Approving the action were board members Dr. W. L. Lukens, John Henry Brown and Marvel Wilkin. Wilfred Faul dissented. Elmer Hedges, fifth member, was absent from the meeting. Board members approving the move said that the revenue raised from the rental would be used for playground purposes.
