

Move to Send Negro Pupils Back to School Is Planned

Parents to Be Notified That Action Illegal

Juvenile authorities said today that parents of Negro children who have been kept out of school during the litigation in U. S. District Court on the injunction suit brought by five local Negro mothers against the school board have been notified to get their children back into school immediately or face court action.

Local officials had refrained from taking any action on the absenteeism until the federal court ruled on the legality of the school board's re-zoning move which sent most of the colored children back to the Lincoln School.

After Judge John Druffel ruled in Cincinnati last week that the move was lawful, local juvenile authorities moved to get the children who have been out of school since September 17 back to the classrooms.

JUST HOW many children have been kept out of school since the school districts were re-zoned is not known. Several parents continued sending their children to the Webster and Washington Buildings for a time after they were re-assigned to the Lincoln Building.

then took them back home after they were refused admittance. A total of 33 children were transferred back to the Lincoln school in the re-zoning move, but many of these abided by the board's action and are in class.

School officials and juvenile authorities have notified the parents of the absent children that unless the children are placed in school immediately, they will be declared delinquent, and charges of contributing to the delinquency of minor children will be placed against the parents.
